### 1. Apologies for Absence

Apologies had been received from Mr Stanger, which were accepted.

### 4. General Matters

(4.1) Action points from last meeting.

The Clerk read out correspondence between himself and Mr Mayes concerning the Reepham Road/Hall Lane junction,. the highways would look again at the site but they felt full safety measures had been taken

Re the effect on businesses when School Road is taking place, Mr Roper would get back to us.

Other items concerning road surfaces, tree roots in Costessey Lane, and foliage over pavements were being looked into.

(4.2) 29 Bus Revised Times

Since this item was put on the Agenda, revised times have been made and published.

(4.3) Speedwatch.

It was decided to ask Speedwatch to target various roads. The roads are:-

- a) Hall Lane
- b) Low Road
- c) Carter Road
- d) Costessey Lane
- e) Pendlesham Rise/ Drewray Drive
- f) Longdale

(4.4) Bus Shelters

The state of the Bus shelters was discussed and what works needed to be carried out to bring them up to standard. It was decided to ask the Handyman to inspect all and report back what improvements needed doing by next meeting. The question of Health and safety matters when work is being carried out and it was agreed to contact the Highways Department for their advice.

(4.5) Possible obstruction into side of Longdale

A letter had been received from a resident concerning a possible obstruction into the Longdale Playing Field. After much discussion, it was agreed to check with Broadland District Council, who the owner was and the legal position of the gate being erected. The matter was to be put on the full Parish Council agenda for discussion.

**5. Exchange of Information**

Mr W Morgan queried if the sign at Drayton Grove had been reported as broken. The Clerk stated it had been replaced that day.

Mr Wilkinson reported the Drayton signs were obscured on Drayton High Road.

Mr Anderson stated the Bus Stop sign at bottom of School Road was covered by foliage.

Mr K Morgan raised the problem of the chicane opposite Hurn Road; it was decided to put on next Highways Agenda.
